Over a dozen actual tasks are presented and broken down into four major categories which I found useful because the approach varies between tasks. Each of the Rigos chapter has one editorialized question that leads me through the file and library as we build our understanding of what resources are presented and how best to combine them into a responsive task answer. Rigos also touches on ethical issues that I have not found in any other MPT book
